Bring all documents including Identification Cards, DD214, Military Records, Medical Records, along with all legal documents you may have. **NO WEAPONS, DRUGS (INCLUDING MEDICAL MARIJUANA), or ALCOHOL IS ALLOWED**

There will be an "Amnesty Box", for any weapons, drugs, or alcohol onsite. If you bring a weapon, drugs, or alcohol to the event, you will be asked to store them off site or dispose of them in the Amnesty Box. If you refuse, you will not be allowed to enter. If you are found with a weapon, drugs, or alcohol in your possession while on site you will immediately be escorted off the property.

We encourage ALL homeless men, women, and veterans with families to attend

- *You may bring your pet(s) as the SPCA will provide veterinary services and kennels.
- *Please bring all medications you need with you. We will store them in a secure place and refrigerated if necessary. You will have access to them when you need them while you attend the stand down.
- *Clothing and Hygiene items will be provided. A safe storage area will be provided for your belongings while you attend the event. You will be given an identification tag when you store your possessions.
- *If you need court services only you must pre-register to be put on the court docket.
- *Transportation will be provided for Friday and Saturday, to and from your location.

Be sure to be at your designated pick-up area no later than 0700 or (7:00am) on Friday June 17th and Saturday June 18th. The busses will return you to your original pick-up location at the end of each day.
